Educational objectives

- 2. Explore the potential for enhancing outcomes for patients with pain through a multidisciplinary approach.
- 3. Review pathophysiology and treatments for opioid use disorder and evidence for commonly prescribed analgesics.

- 5. Analyze strategies for overcoming practice obstacles including payment structure, risk management, and diversifying practice patterns.
- 6. Discuss approaches to managing acute or chronic pain in trauma and perioperative settings.
- 7. Summarize advances in research methodologies to assess outcomes of treatments for pain.
