

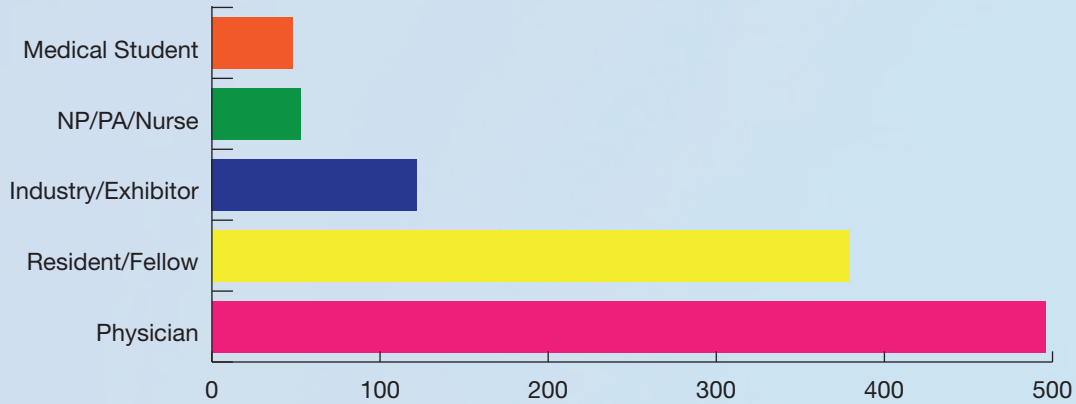
Industry Supported Non-CME Ancillary Events

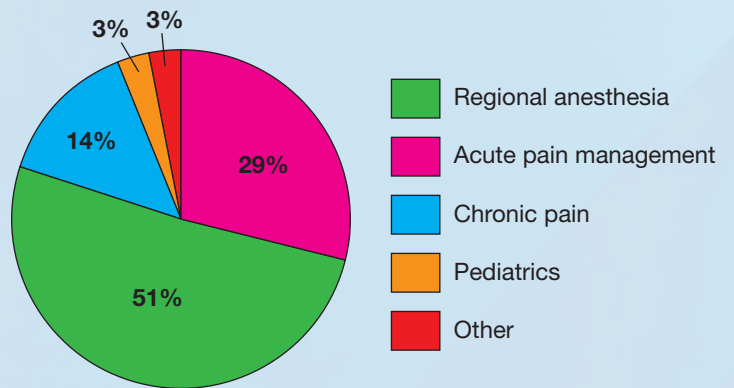

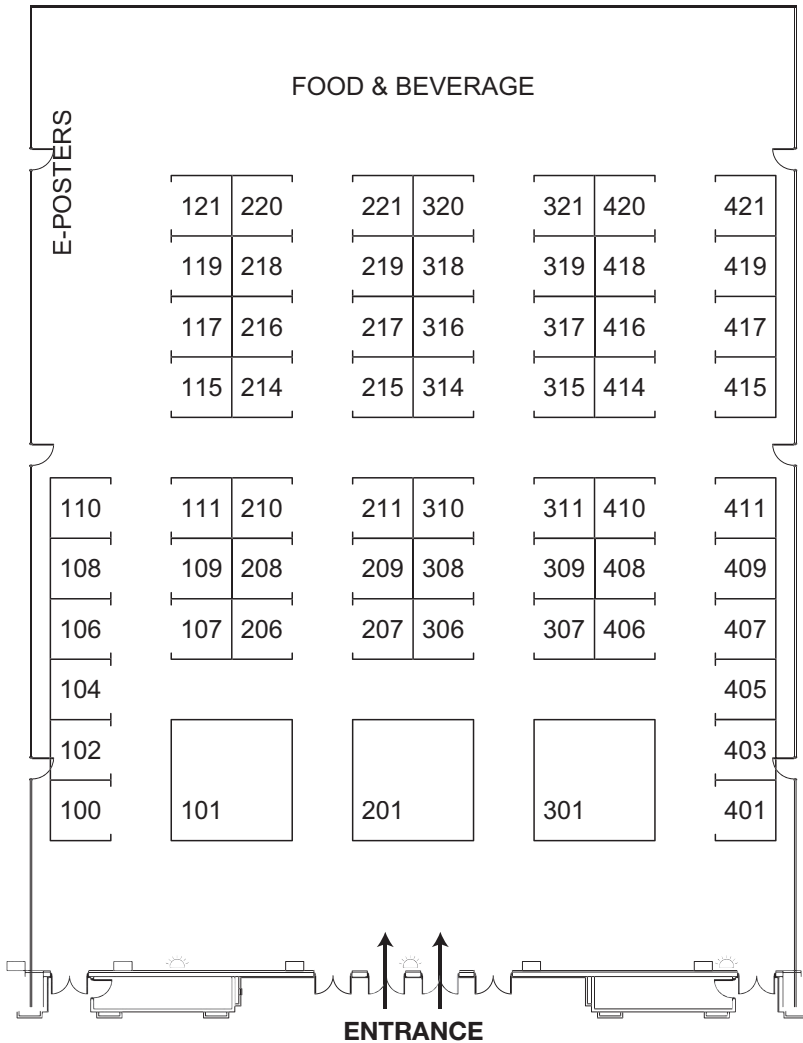

ASRA Pain Medicine Guidelines for Assignment of Space:

The priority points system has been established to fairly assign space at all ASRA Pain Medicine meetings and events. Point totals are based on the 12 months preceding December 6, 2024, the date booking forms must be received to benefit from the point system.

- All requests for space must be submitted by the sponsoring company via the official booking form.
- Earliest submitted forms will have preference if companies reach equal point totals. If forms arrive on the exact same date, ASRA Pain Medicine reserves the right to assign space based on a company's previous support of ASRA Pain Medicine.

- All official ASRA Pain Medicine space requirements will be met prior to any assignment of space required by industry.
- Assignment of exhibit hall exhibit space will begin after December 20, 2024.
- Assignment of other function space will begin January 27, 2025.

Exhibitor Personnel Registration *
